INTRODUCTION:

The 2021 year ended with an average annual inflation rate of 3.4% which is well above the 2% seen in recent years. The last three months of the year saw inflation rates above 4.5% and in January the trend continued with a rate of 5.1%. In short, these unprecedented rates of inflation and their impact on prices could not have been foreseen when the budget was drafted in November 2021. In addition, the continued uncertainty and volatility of the markets, particularly for fuel, adds to the challenge of accurately forecasting the impact that all of this will have on the 2022 budget

INCREASES NOT INCLUDED IN THE 2022 BUDGET:

Therefore, the revised deficit now is:

OPTION 1:

The budget presented in December proposed a 2.13% tax rate increase that represented \$253,561 in revenue to balance the budget. Taking into account the additional known increases presented above, a proposed tax rate increase of 4.53% would be required to meet the revenue shortfall of \$557,161.

OPTION 2:

The second option proposes to eliminate capital projects in order to reduce the amount of money needed to balance the budget while keeping the tax increase as low as possible. That being said, the vast majority of road projects are funded from grants or cannot be deferred for various reasons. The following are proposed:

With this option, the proposed tax rate increase of 2.13% would be increased to 2.83% to balance the budget.

- approves that the cost of engineering fees be paid from reserves.
