## Highlights & Accomplishments

<u>3D printers:</u> We are working on the operation of the 3D printers. One printer is already installed in St Albert and one in St Isidore. One will be installed in Limoges shortly.

<u>Update on connectivity</u>: Unfortunately what was planned for the end of October was cancelled by the agency who is doing activation in cooperation with Bell Canada. For the moment, it is planned for Wednesday November 23 in Limoges and Thursday November 24 in St Albert. In Limoges, the wiring is done so only activation remains to be done.

**Panic buttons**: Good news. We now have stable and mobile panic buttons in all three (3) branches.

<u>Orientation for Municipal Council 2022-2026</u>: Wednesday November 9, we presented the services and information on the library to Counsellors with all the other municipal services. A file of information on public libraries in Ontario, a pen, and a key chain with the Nation Logo printed on our 3D printer was given to each member.

**Posting for the new member of the Library Board**: Following the notice that was posted on Facebook, we received three (3) applications. To make a selection, it would be preferable to have a subcommitte to review the applications and make a recommendation that will be presented to Municipal Council by the CEO.

**Book Sale**: We will participate in the Book Sale at the Nepean Sportsplex organized by the Ottawa School Boards on December 7th, 2022.

<u>Christmas activities:</u> We are currently working on Christmas Arts and Crafts for the trois (3) branches.

<u>Succursale Limoges Branch:</u> The Limoges branch was closed on Friday November 4 and Saturday November 5 due to the uncertainty with events around the employees of the Catholic School Board.

<u>Succursale St Albert Branch:</u> We have started our visits to Ecole St Albert. We bring a case of books in the name of the teacher. Then we exchange the books on a monthly basis.

#### INTRODUCTION

In developing the 2022 budget, Council established funding for water and sewer infrastructure projects. In January 2022, Council approved temporary financing to fund the costs during the year. The projects are now completed, and the temporary borrowings must be converted to long-term borrowings primarily because the temporary borrowings are at a variable rate which is greatly affected by changes in the prime rate. The purpose of this report is to inform Council of the precise amount of the loans and the financial impact.

#### **FINANCING**

The temporary loans are with the Caisse Populaire and it is the Caisse that had the best rates for a loan with the option of additional annual repayment. It is therefore recommended that the municipality stay with the Caisse and that we convert the temporary loans into long-term loans.

#### **FINANCIAL IMPACT**

#### WATER - CHENEY TO LIMOGES WATERMAIN

The project cost is \$15,432,240 less the reserve amount of \$2,610,124. Therefore, the net cost, and the amount of the loan, is \$12,822,116. The impact of such a loan is:

Given that we have the option of making additional repayments on an annual basis, a term of 300 months with a 60-month amortization is recommended. # **CONTEXT:**

When taxes are in arrears by more than two years, the property is eligible for tax registration. This was done internally in the past as there was a limited number of properties from year to year. However, in 2020, emergency measures were imposed by the province which put a freeze on all tax collection procedures. The measures having been lifted last July left us with a higher than usual amount of properties with taxes in arrears and for which tax registration procedures must be started.

# **CONSIDERATIONS:**

As seen in the table in Schedule A, the tax registration process is lengthy and detailed. Forms must be filed on precise dates based on set timelines for the procedures. A strict follow-up is required on files to ensure no deadlines are missed or the process begins anew. This can become quite time consuming and anyone doing this must be up to date on legislative changes. Seen this, several municipalities in Ontario outsource this service to a third party.

Outsourcing this service makes sense because:

- A third party has the in-depth knowledge concerning tax registrations & tax sales since this is their expertise.
- A third party is up to date on legislation surrounding the tax registration process. Although this legislation doesn't change often, they would be on top of coming changes.
- A third party has the tools to ensure a proper and exact follow up of each file is done so no deadlines are missed.
- A third party is familiar with and better able to complete the various online forms ensuring the process is done correctly.
- A third party will allow a timelier collection of tax arrears since files will be addressed shortly after falling into arrears rather than being set aside due to lack of time.

Please note that outsourcing this service does not relinquish our responsibility in terms of collection because the third party prepares documents and performs the follow-ups on our behalf. The Nation is still responsible for signing all documents which are then sent to the taxpayer *on our behalf*.

The Nation has reached out to two organizations specializing in tax registration, The Tax Team & Realtax. Both offer the same services, but the main difference lies in the fact that The Tax Team circulates documents for signature via email and courier while RealTax uses Docusign, email and courier. Seen the fact that residents can pay at any time, both invoice as the file progresses.

# **FINANCIAL CONSIDERATIONS:**

Overall, the difference in cost between those charged by The Nation and those charged by the third parties is similar. Thus, there will be no major impact on the amount charged to the roll.

# **CONCLUSION:**

For the reasons outlined above, outsourcing the tax arrears collection & registration process is a logical step for The Nation. The small difference in cost is offset by the savings found in time and efficiency of this process due to outsourcing. As well, it adds no additional costs to the municipality since the fees invoiced by the third party are charged back to the roll.

Other municipalities in Prescott-Russell already outsource their tax registration/arrears collection and are quite happy with the services and believe is saves a lot of time, takes away a lot of the follow-up and difficulties in filing the various forms.

It is recommended that the service be outsourced to RealTax mainly because the transfer of documents is done with Docusign, allowing for a smoother transfer and more efficient and safer approval of documents.

Should council decide to accept this proposal, the proposed by-law is included in Schedule B.

# REPLACING SWIMMING POOL BY-LAW 80-2005 REPORT PLA-3-2023

Date of meeting: February 27th, 2023

#### INTRODUCTION:

A property owner has submitted a letter (Annex 1) requesting that Council grant an exception to the pool by-law to install a 4-foot-high fence instead of a 5-foot-high fence for his in-ground pool, as prescribed by By-law 80-2005.

The Building Department is of the opinion that we should adopt a new By-law to allow this exception but for the whole municipality.

#### RECOMMENDATION OF THE BUILDING DEPARTMENT:

It is important to inform Council that the pool by-law is under the jurisdiction of municipal law and not the building code. This allows municipalities to pass a by-law to legislate pools but does not require them to do so.

Some municipalities do not have a pool by-law, but The Nation has always preferred to have one to have some control over the location of pools and promote safety.

Insurance companies submit to the wishes of the municipality in question and do not require homeowners to have fences.

In December 2017, Ms. Brizard shared with us a report of an incident that took place in one municipality.

Basically, the recommendations were that although it is not mandatory, municipalities should be proactive.

We tried to find the exact reason why a fence around an in-ground pool must be 5 feet and an above-ground pool must be 4 feet. We haven't really found a good reason for the difference.

Following the request, the department recommends that Council adopts By-law 18-2023, replacing By-law 85-2005 to correct the height of the fences.



#### **INTRODUCTION:**

On April 25<sup>th</sup>, 2022, the municipality held a public meeting regarding an amendment to Zoning By-law 2-2006 to allow residential uses within the Oasis PH subdivision. 3.

As you will recall, 1750739 Ontario Inc. has applied to amend Zoning By-law 2-2006, file ZBL-3-2022, in respect of the property located on a portion of Lot 29, Concession 2 in the former Township of Cambridge to permit the construction of the proposed subdivision under file 070-S-15-01. This subdivision features a mix of housing types such as single family, semi-detached, row and apartment units. This zoning amendment is to reflect the different uses within this subdivision. (APPENDIX 1A ORIGINAL OPTION & APPENDIX 1B DEFERRED OPTION, AS PER RESOLUTION 205-2022)



#### **PROVINCIAL POLICY STATEMENT 2020**

Under section 1.1.1, the PPS cites that in order to maintain healthy and safe communities, we must:

- (a) encourage efficient forms of development and land use that support the long-term fiscal vitality of the province and municipalities;
- (b) allow for an appropriate range and diversity of residential (e.g., second dwelling units, affordable housing, seniors' housing), employment (including industrial and commercial), institutional (e.g., places of worship, cemeteries, long-term care homes), recreational, open space, outdoor and other uses to meet long-term needs; .....
- (e) encourage cost-effective forms and standards of development that minimize land use and servicing costs;

Under section 1.1.3, the PPS encourages the development of mixed-use residential in urban centers. The PPS encourages municipalities to redevelop settlement areas by densifying existing land within villages. This densification should maximize existing infrastructure.

Under Section 1.4.3, the PPS directs us to provide an appropriate diversity and range of housing types and densities to meet the needs of current and future residents of the regional market area by:

- (a) establishing and implementing minimum goals for the provision of affordable housing to low and moderate income households....
- (b) by enabling and facilitating:
- a. all forms of housing necessary to meet the social, health, and welfare needs, including special needs, of current and future residents;
- b. all forms of residential intensification, including second dwelling units, and redevelopment in accordance with Policy 1.1.3.3;
- c) directing new housing development to locations where appropriate levels of infrastructure and public service facilities are or will be available to meet current and future needs
- (d) encouraging densities for new housing that make efficient use of land, resources, infrastructure and utility facilities, and that support the use of active transportation and public transit in areas where they are available or to be located
- (e) establishing development standards for residential intensification, redevelopment and new residential development that minimize the cost of housing and facilitate compact development, while maintaining appropriate levels of public health and safety.

Under Section 1.6.6.1, the PPS encourages us to direct and respond to planned growth or development in a manner that promotes the efficient use and optimization of existing municipal sewer and water services.

Also, in Section 1.6.6.2, the PPS cites municipal sewer and water services as the preferred method of servicing settlement areas. Wherever possible, densification and redevelopment based on existing municipal sewer and water services should be encouraged in settlements.

The by-law amendment application meets the PPS.

#### **OFFICAL PLAN:**

The property is listed under the "Urban Policy Area" in Schedule A of the Official Plan of the United Counties of Prescott and Russell.

Policies 2.2.6 & 2.2.7 on residential development encourage a mix of residential and commercial uses within urban areas and to densify even the core areas of our urban areas.

The policy (2.2.6.5) considers a mix in an urban area to be about 70% low density, 20% medium density and 10% high density.

In this case, the Planning Department calculated an approximation of the ratio at 45% low density (14 singles, 48 semi-detached), 35% medium density (49 rang.) and 20% high density (28 apt.). By studying the urban area of the village of Limoges, we know that the low-density ratio is much higher than the rest of the densities, given its history. The Oasis PH. 3 subdivision does not drastically change the ratio that we are trying to maintain within the urban area.

In fact, according to the current economy, the market is moving towards medium density housing units, i.e. row houses. These homes allow young families to settle into the community and nurture the community spirit that the PPS encourages us to develop.

The Planning Department can confirm that the zoning by-law amendment meets the intentions of the Official Plan.

#### **ZONING BY-LAW:**

The property in question is zoned "residential low density – Holding (R1-H)".

The purpose of the amendment is to modify the zoning category of the proposed subdivision but also to introduce more modern provisions with respect to land use.

Below is a listing of the exception zone provisions that we are looking for the subdivision. The provisions for townhouses and apartments are the only ones to change (ANNEX 2)

Notwithstanding Section 5.5, "High Density Residential Zone" of Zoning By-Law 2-2006, hereof to the contrary, on the land zoned R3-X30 the following provisions shall apply:

Permitted use only: -Row dwelling (4 units max.)

-One (1) Row dwelling (5 units max.) within the

whole Oasis PH.3

Provisions:

Minimum lot area 180 m² / per dwelling unit Minimum lot frontage 6 m. / per dwelling unit

Front yard 7.5 metres
Rear yard 6 metres
Exterior Side Yard 5 metres
Interior Side Yard 2.45 metres

Max. Lot Coverage 55%

Minimum driveway setback

from side lot line between blocks of land 1.8 metres

#### COMMENTS DURING APRIL 25th, 2022 PUBLIC MEETING

In summary, the public comments asked what would happen to the use behind the houses on Mayer Street. According to the land exchange agreement between the developer and the municipality and supported by resolution 205-2022, row houses and the park will be behind these houses. There is no more apartment complex proposed within the subdivision.


Also, the same type of comment was raised by the South Nation Conservation and following this exchange, their concern regarding this parcel is now partially resolved.

In closing, Mr. Warren asked that the public be involved in the Savage Street concept. This will be a decision of Council.


#### PLANNING DEPARTMENT RECOMMENDATION:



#### **BY-LAW NUMBER 18-2023**

#### SWIMMING POOL ENCLOSURE BY-LAW

**BEING A BY-LAW** of the Corporation of The Nation Municipality respecting the enclosure of privately-owned outdoor swimming pools.

**WHEREAS** Section 11(1) 7. of The Municipal Act, 2001, as amended, provides that the Council of a Municipality may pass by-laws respecting matters within certain spheres of jurisdiction namely, among other things. "7. - Structures, including fences and signs" and,

WHEREAS The Corporation of The Nation Municipality deems it desirable to regulate owners of privately-owned outdoor swimming pools to erect and maintain fences and gates around such swimming pools, for prescribing the height and description of, and the manner of erecting and maintaining, such fences and gates, for prohibiting persons from placing water in privately-owned outdoor swimming pools or allowing water to remain therein unless the prescribed fences and gates have been erected, for requiring the production of plans of all such fences and gates, for the issuing of a permit for any such fences or gates;

THEREFORE, the Council of The Nation Municipality enacts as follows:

# SHORT TITLE

**1.** This By-Law may be cited as the "Swimming Pool Enclosure By-law".

#### **DEFINITIONS**

- 2. In this By-Law:
  - (a) "Municipality" shall mean The Corporation of The Nation Municipality.
  - (b) "Permit" shall mean permission or authorization given in writing by the Chief Building Official to erect enclosures around swimming pools as regulated in this By-Law.

- (c) "Swimming Pool" shall mean any privately-owned outdoor below grade or above ground pool of water for bathing, wading or reflecting and which has a water depth exceeding twenty four (24) inches at any point; but does **not** include a tub, hot tub, spa, whirl pool, or inflatable self-supported pool.
- (d) "Owner" shall mean the registered owner of the land and includes a lessee, mortgagee in possession, and the person in charge of the property;
- (e) "Chief Building Official" shall mean the Chief Building Official appointed by the Council of the Corporation of The Nation Municipality;
- (f) "Corporation" shall mean the Corporation of The Nation Municipality.

#### **GENERAL REQUIREMENTS**

- 3. Every owner of a privately-owned outdoor swimming pool shall ensure that an enclosure around such a pool is constructed and maintained according to the provisions of this By-Law.
- 4. No person shall place water in a swimming pool in the Municipality unless the prescribed fences and gates or, for a maximum period of thirty days, a temporary fence as approved by the Chief Building Official has been erected in accordance with the provisions of this By-Law.
- No person shall allow water to remain in a swimming pool in the Municipality unless the prescribed fences and gates or temporary fence has been erected in accordance with the provisions of this By-Law.

# **PERMITS**

6. No person shall construct or place a swimming pool on his property in the Municipality without first obtaining a swimming pool enclosure permit.

#### **APPLICATION FOR PERMIT**

- 7. To obtain a permit the owner shall file an application in writing by completing a prescribed form available in the office of the Chief Building Official.
- 8. Except as otherwise permitted by the Chief Building Official, every applicant shall:
  - (a) identify and describe in detail the work to be covered by the permit for which an application is made,
  - (b) describe the land on which the pool is to be located by a description that will readily identify and locate the building lot,
  - (c) be accompanied by two (2) complete sets of plans showing details of the enclosure and deck as well as their relationship to lot lines, buildings and fences,
  - (d) be accompanied by the fee as prescribed in Section 11 hereof, and
  - (e) state the names, addresses and telephone numbers of the owner and the contractor performing the work.
- 9. An application for a permit may be deemed to have been abandoned and cancelled six (6) months after the date of filing, unless such application is being seriously proceeded with.
- 10. Sufficient information shall be submitted with each application for a permit to enable the Chief Building Official to determine whether or not the proposed work will comply with this By-Law or any other applicable law or regulation.
- 11. The fee for a swimming pool enclosure permit shall be \$100.00.
- 12. An administration performance deposit of \$100.00 shall accompany an application for a swimming pool enclosure permit. The full amount of the administration performance deposit is to be refunded in whole or in part to the permit holder in accordance with the following provisions;
  - (a) One hundred (100%) per cent of the administration performance deposit is to be refunded if the installation is fully completed within one (1) year of the date of the issuance of the permit.

- (b) Seventy-five (75%) per cent of the administration performance deposit is to be refunded if the installation is fully completed within two (2) years of the date of the issuance of the permit.
- (c) Fifty (50%) per cent of the administration performance deposit is to be refunded if the installation is fully completed within three (3) years of the date of the issuance of the permit.
- (d) Twenty-five (25%) per cent of the administration performance deposit is to be refunded if the installation is fully completed within four (4) years of the date of the issuance of the permit.
- (e) No refund of the administration deposit will be awarded if the installation is not fully completed within four (4) years. This will not relieve the permit holder and/or contractor of obligations under any provisions of any By-Law, the Building Code Act or regulations made thereunder.
- (f) The refund of the whole or part of the administration performance deposit shall not be deemed to be a waiver of any provisions of any By-Law or requirements of the Building Code Act or regulations made thereunder. Also, the refund should not be construed as a certification or guarantee that the installation for which a permit was issued meets all the requirements of any By-Law, the Building Code Act or regulations made thereunder.

#### **CONDITIONS OF PERMIT ISSUANCE**

- 13. (1) Every swimming pool shall have an adequate enclosure erected around it in accordance with the provisions of subsection (2) to subsection (8) hereof inclusive.
  - (2) Every enclosure for a swimming pool shall be of a close-boarded, chain link or other approved design with maximum openings of 4" including the space below the fence, to reasonably deter children from climbing it to gain access to the fenced-in area.

- (3) In the case of an in ground pool, the enclosure shall be at least 4 feet in height but no more than 8 feet and in the case of an above ground pool, if the walls of the pool are less than 4' high above the grade for a distance of at least 24 inches from the wall, the enclosure shall be at least 4 feet in height but no more than 8 feet or the walls of the pool can be extended with an approved manufactured fence for a total height of at least 4 feet above the grade.
- (4) Gates in the enclosure shall:
  - (a) provide protection equivalent to the enclosure,
  - (b) be at least the same height as the enclosure,
  - (c) be equipped with a self-closing and latching device and lock at the upper inside of the gate, and
  - (d) be locked except when the enclosed area is actually being used and supervised.
- (5) Barbed wire or fencing energized by electrical current shall not be used as an enclosure for the swimming pool.
- (6) Where a wall of a building is used as part of an enclosure, all doors located in the wall of the building shall be equipped with locking devices.
- (7) Equipment or materials cannot be located, stored or kept within 36 inches from the pool to prevent climbing.
- (8) Decks or platforms associated with pools shall comply with the requirements of the Ontario Building Code and the access to such decks or platforms must be adequately enclosed in accordance with subsections (2) to (6) hereof inclusive.
- 14. There shall be a minimum distance of four (4) feet between the enclosure and any part of an in-ground swimming pool unless approved otherwise by the Chief Building Official.
- 15. When an enclosure is not erected or maintained, in accordance with the provisions of this By-Law, a notice shall be sent by registered mail or by hand to the owner of the land on which the swimming pool is located, at his last known address requiring him to make the enclosure conform to the requirements of this By-Law and the notice shall specify the time allowed for compliance.

- 16. (1) Where a notice has been sent pursuant to Section 15, and the requirements of the notice have not been complied with, the Chief Building Official may cause the work to be done, or the water to be removed from the swimming pool and the cost of the work or the removal of the water shall be at the expense of the owner.
  - (2) When the Chief Building Official causes the work to be done pursuant to subsection (1), the Corporation shall have a lien for any amount expended by or on behalf of the Corporation and for an administrative fee of ten (10%) percent of any amount expended by or on behalf of the Corporation, and the certificate of the Clerk of the Corporation as to the total amount expended shall be admissible in evidence as prima facie proof of the total amount expended and such total amount together with the administrative fee shall be added to the collector's roll of taxes to be collected and shall be subject to the same penalty and interest charges as real property taxes and shall be collected in like manner and with the same remedies as real property taxes.
  - (3) Before the certificate of the Clerk of the Corporation is issued under subsection (2), an interim certificate shall be delivered to the owner of the property that is subject to the lien, as well as to all prior mortgagees or other encumbrancers and the affected owner, mortgagees or other encumbrancers shall have two (2) weeks from the date of receipt of the interim certificate to appeal the amount shown thereon to the Council of the Corporation.
- 17. The provisions of this By-Law also apply to swimming pool enclosures which have been constructed or installed prior to the passing of this By-Law.

# **PENALTIES**

18. Every person who contravenes any of the provisions of this By-law is guilty of an offence and on conviction thereof shall forfeit, and pay a penalty for each such offence and every such penalty

and pay a penalty for each such offence and every such penalty shall be recoverable under the Provincial Offences Act, R.S.O. 1990, chapter P.33 and amendments thereto.

- 19. When a person has been convicted of an offence under this By-law, any court of competent jurisdiction thereafter, may, in addition to any other penalty imposed on the person convicted, issue an order prohibiting the continuation or repetition of the offence or the doing of any act or thing by the person convicted directed toward the continuation or repetition of the offence.
- 20. The requirements of this By-Law are severable. If any requirements of this By-Law are held invalid, the application of such requirements to other circumstances and the remainder of this By-Law shall not be affected.
- 21. This By-Law shall come into force on the date of its adoption and shall take effect on that date.
- 22. That By-Laws # 80-2005 hereby repealed.



- If an activity is deemed discriminatory, contrary to municipal policies and values, or unlawful;





#### **About ALUS**

ALUS is a national charitable organization that provides expertise, resources, and direct financial support to 35 communities across six provinces where more than 1,400 farmers and ranchers build nature-based solutions on their land to deliver ecosystem services to sustain agriculture, help build community resilience and fight climate change and biodiversity loss for the benefit of communities and future generations.

#### **ALUS Ontario East**

Originally established in 2022, ALUS Ontario East now generally operates within the Raisin Region and South Nation Conservation Authority jurisdictions. With the support of its legal entity, the Raisin Region Conservation Authority, the program is governed by a Partnership Advisory Committee (PAC) led by ten local farmers along with several advisory, non-voting members from various partner organizations. ALUS Ontario East supports the establishment, management, and maintenance of various innovative and sustainable projects such as wetlands and beaver baffles, erosion control, buffers, windbreaks, grasslands, modified grazing practices, livestock exclusion fencing, and more.

ALUS shares many priorities in common with our municipalities, such as sustainable land use, cleaner water, and resilient communities. To date, we have been privileged to partner with over 62 landowners and local organizations to establish 138 projects on 783 acres within Eastern Ontario.

### What is ALUS?

ALUS (originally an acronym for Alternative Land Use Services) is a national charitable organization that provides expertise, resources, and direct financial support to 35 communities across 6 provinces where more than 1,400 farmers and ranchers establish and steward nature-based solutions on their land. These solutions deliver ecosystem services to help sustain agriculture and fight climate change and biodiversity loss for the benefit of communities and future generations.

Projects such as enhanced wetlands, windbreaks, riparian buffer zones, wildlife habitats, adaptative agricultural practices and other impactful environmental solutions produce cleaner air, cleaner water, greater biodiversity, carbon sequestration, erosion control, flood and drought mitigation, pollinator and wildlife habitat, and other ecological services.

### **ALUS Ontario East**

ALUS came to eastern Ontario in 2012. Today, ALUS Ontario East generally operates within the Raisin Region and South Nation Conservation Authority jurisdictions. The program is led by the local Partnership Advisory Committee (PAC) with assistance from its legal entity, the Raisin Region Conservation Authority. The PAC is comprised of members from both the local farming and environmental communities.

ALUS Ontario East works with farmers and ranchers to enhance ecosystem services on marginal, inefficient, and fragile areas and on lands that can be managed in a different manner through projects that best suit their farming

operations. ALUS participants receive an annual payment for every acre enrolled in the program in exchange for managing and maintaining projects that increase ecosystem services to that benefit both their farm and wider community.

ALUS is voluntary and non-prescriptive, which allows for increased flexibility when designing projects to suit any farming operation. The program is always on the lookout for interesting and innovative project ideas that will bring together agriculture and nature.

Participating local farmers provide both financial and in-kind contributions to establish and maintain stewardship projects on their properties, thus playing an integral role in the overall success of the program. ALUS Ontario East recognizes their stewardship efforts and endeavors to augment them by offsetting some of the costs associated with the establishment, management, and maintenance of these projects.



# **Partnership Advisory Committee (PAC)**


The ALUS Ontario East Partnership Advisory Committee (PAC) oversees the coordination and implementation of the ALUS program within the local community. The PAC is comprised of local farmers as well as non-voting advisors from various agricultural, environmental, and community organizations. The PAC consists of 10 voting members, all of whom are farmers distributed throughout the ALUS Ontario East area of operation.

The farming members of the committee provide direction on stewardship priorities, budget, project approvals, management and maintenance payments, and outreach. The current advisory members consist of representatives from the Raisin Region Conservation Authority, South Nation Conservation, Ontario Woodlot Association – Stormont, Dundas and Glengarry Chapter, Boisés Est, Ducks Unlimited Canada, the Ontario Ministry of Agriculture, Food and Rural Affairs, and ALUS.

# **Projects Summary**

ALUS Ontario East supports the establishment, management, and maintenance of a variety of innovative and sustainable project types. These include among others:

- Wetlands
- Beaver baffles
- Erosion control
- Buffers, windbreaks and edible forests

WHEREAS the Government of Ontario recently passed Bill 23, More Homes Built Faster Act, 2022 without providing meaningful or adequate opportunity for municipalities to provide input on ways to increase the supply of housing and to improve housing affordability in Ontario while ensuring the financial capacity of municipalities to support growth and protection of the environment;

**AND WHEREAS** Bill 23 will have significant negative impact on, green standards, environmental protection of wetlands, conservation, social housing and other significant areas of concern;

**AND WHEREAS** Bill 23 will negatively impact municipalities' ability to manage growth, fund essential services and provide new infrastructure for the community resulting in fewer affordable housing units and putting pressure on the municipal tax rate by freezing, reducing, and exempting fees and development charges;

**AND WHEREAS** Bill 23 will have a negative environmental impact by removing the Conservation Authority's ability to review and consult on developments impacting natural heritage and conservation;

AND WHEREAS Bill 23 will result in reduced parkland for municipalities;

**AND WHEREAS** Bill 23 will open up the Greenbelt for development when the Greenbelt should remain an environmentally protected area so it can continue to help with flood control, provide clean air, and protect us from natural disasters;

**AND WHEREAS** a preliminary analysis of Bill 23 by the Association of Municipalities of Ontario (AMO) indicates the transfer of up to \$1 billion a year in costs from private sector developers to property taxpayers without any likelihood of improved housing affordability while also undermining environmental protection;

**AND WHEREAS** a growing number of municipalities have joined in expressing their concern with the negative impacts of Bill 23;



Re: Your response to our petition for the Designation of a proposed cement plant project near L'Orignal, Ontario as a Designated Project under the Impact Assessment Act (2019)

Action Champlain is in receipt of your November 2, 2022 letter stating that you have rejected Action Champlain's request to designate the proposed Colacem Inc. cement plant ("the Project") as a designated project for assessment under the Canadian Impact Assessment Act ("the Act").

Action Champlain hereby requests that you reconsider your decision and designate the Project for assessment under the Act. Based on legal advice received, Action Champlain takes the view your decision is not correct in law and further is not a reasonable decision in the circumstances.

Following our meeting with the Impact Assessment Agency of Canada, we disagree strongly with most of the arguments that they presented in their slide-deck for rejecting our petition. Please see the Appendix at the end of this letter for details of where we believe that they erred.

In our opinion, the IAA does not seem to have given any credence to the validity of our 240 page Designation Request support document. Specifically, we feel that the IAA did not:

- take into account the Material change in the Project's geographic area which increased by over 312% in 2021
- verify that consultation had effectively occurred with Indigenous communities listed by the proponent
- realize the extent of cumulative effects on the environment, on critical habitats, on migratory birds and on species at risk on the expanded geographic area and beyond
- realize that transboundary pollution into Quebec will be very significant

- verify the greenhouse gas emissions that the project will cause by having heavy duty diesel transport trucks driving over 9.5 million kilometres a year
- consider the fact that the project would be emitting 832,942 metric tonnes a year of greenhouse gas from the kiln operation alone for the next 50 years, for a total of 42Mt

Minister Guilbeault, if you read our comments below, you may truly appreciate the scale of the problem and the urgency to prevent the environmental catastrophe that is about to happen if there is not an impact assessment conducted under your authority.

**First**, your letter states that "Since there have been no material changes to the Project, there is no basis to revisit the former Minister's determination".

Action Champlain takes the view that this finding is demonstrably incorrect. Since your 2018 review, the Proponent expanded the geographic area covered by the Project, in 2021, from 56 hectares to 174 hectares to include its adjacent quarry lands. Significant woodlands and wetlands on the quarry lands will be destroyed in order to mine limestone required to produce cement at the proposed cement plant. Action Champlain maintains that the fact that the estimated cement production is not proposed to increase by virtue of the inclusion of the quarry lands in the project is not relevant. What is relevant is that environmental and other impacts of the Project will be greater due to inclusion of the quarry lands in the Project. That is a material change in circumstances that obliges you to revisit the former Minister's determination. As pointed out in our Petition, it changes the scope of the Project.

**Second**, your letter states that "there were both provincial and federal regulatory mechanisms in place to . . . provide opportunities for . . . Indigenous participation."

This is a fundamental and egregious misstatement of the Crown's constitutional and international legal obligations with respect to consulting with Indigenous nations on proposed developments.

Article 32 (2) of The United Nations Declaration on the Rights of Indigenous Peoples--which Parliament has affirmed pursuant to the eponymous statute enacted last year--provides that "States shall consult and cooperate in good faith with the Indigenous peoples concerned . . . in order to obtain their free and informed consent prior to the approval of any project affecting their lands or territories, particularly in connection with the development, utilization or exploitation of mineral, water, or other resources."

Further, the Supreme Court of Canada has held in numerous decisions that the Crown has a constitutional duty to consult Indigenous nations on proposed development projects to a standard that far exceeds merely providing opportunities for Indigenous participation.

You have also been informed directly by Grand Chief Victor Bonspille of the Mohawk Council of Kanesatake, that no such consultations with their First Nation have occurred to date. Kanesatake is the nearest First Nations community to the Project, located 50 kilometers downwind and downstream from the Project site.

**Third,** we strongly believe that the project will be exceeding air quality standards almost daily and we know that the IAA cannot refute this statement if they refer to our petition. We also believe that there will be massive episodic acidification and episodic pollution within a minimum radius of 20 kilometres from the project (well into Quebec and the Ottawa River).

These have the potential to extensively contaminate or destroy the environment, affecting critical habitats, migratory bird species, aquatic species, fish and fish habitats, **all of which are within federal jurisdiction**. Furthermore, 15 of the pollutants that will be emitted by the project are extremely persistent, can bio-accumulate for years, and are toxic or carcinogenic. They have the potential to accumulate in plants, milk, fish, native birds, migratory birds, meat and eggs.

**Fourth,** interprovincial and international transports are issues that we feel are extremely important and they were not addressed in the Impact Assessment Agency's slide deck<sup>1</sup> other than being listed in the table on page 15 "Effects raised in 2022 Letter". **We believe that they are within federal jurisdiction**.

Annually, a total of 207,792 tonnes of gypsum, petroleum coke and bauxite will be imported by cargo ships in Montreal ports and up to 811,195 tonnes of cement powder will be exported from Montreal ports to international or national destinations. To and from the Project's site, the raw materials or finished products will be carried by 35 tonnes heavy duty diesel transport trucks. These will have transboundary impact in the province of Quebec, possibly in other provinces and internationally.

**Fifth,** the greenhouse gas emissions (GHG) from the Project were not seriously considered by the IAA, in our opinion. Effectively, following the facts presented in our petition, **the IAA deliberately chose to believe the proponent's figures despite our proofs** that there were numerous and serious errors in the documents that they had received from the proponent.

We assert that GHG emissions from the Project will be at least as high as the provincial benchmark for an average Ontario cement plant, not including the GHG produced by 35 tonne transport trucks driving 9,598,127 kilometers a year or the GHG emissions of cargo ships.

This Impact Assessment is required to examine the extent to which the Project contributes to or detracts from Canada improving its sustainability or achieving its international commitment with respect to climate change.

# **APPENDIX**

# Our comments concerning the slide deck from the Impact Agency file: 2022-11-22\_Presentation to Action Champlain.pdf<sup>2</sup>

# 1- On page 7.

The IAA states that "Direct loss of fish habitat will occur due to the removal of two drainage ditches during construction"

This is a gross understatement. Numerous drainage ditches and the Drain Charlebois itself will be destroyed on the west and north side of the expanded 174 hectares lot of the Project (see Appendix 6, Section 4 of our petition).

# 2- Also on page 7.

The IAA states that "Stormwater management would be designed according to Provincial design requirements"

We believe that the Project has not anticipated and has not taken into account the excess precipitations and the extreme weather conditions that happen regularly now. Consequently, the risks of potential overflow, overspill, discharge, and runoff of contaminated water are extremely high in any given year, and several times within a year. The contaminated water could flow directly in the Drain Charlebois which then drains directly into the Ottawa River or runoff could first get into the quarry and then be accidently pumped into the Drain Charlebois (see Appendix 6, Section 7). The quarry has a permit to pump water with a maximum volume of 6,336,000 litres per day which represents 2,312,640,000 litres per year into the drain Charlebois and there does not seem to be any contingency measures in place to prevent accidently pumping contaminated water from the quarry into the Drain Charlebois.

# 3- *On page 8.*

The IAA refers to the Provincial Environmental Compliance Approval (air) (ECA).

As described in our Petition (Appendix 4), it has been proven that the ECA (air) was granted based on numerous errors, omissions and misrepresentation within the proponent's documents submitted. The Agency's response refers only to compliance of regulations post-construction and does not contribute to making an informed decision on this major project BEFORE construction.

This project requires an impartial, credible and complete assessment in order to ascertain figures. We firmly believe that this will bring to light emission figures that will greatly surpass those submitted by the project proponent.

We believe that no agency, institution or organisation has any idea of the magnitude of the emission levels that will be discharged by this Project, let alone their potential adverse effects. So, how could they comply with an ECA based on grossly underestimated values?

# 4- Also on page 8.

The IAA writes "The Province received further assessment from the proponent to demonstrate contaminants will not leave province, and that there will be no cumulative effect with other local projects".

The "will not leave province" statement is, in our opinion, speculation rather than factual since it is not based on facts, on science and on objective values (see Section 7.3.1, 7.12, and Appendix 4 of our petition for full details). Not knowing any of the level of emissions, it is impossible for the proponent to claim that contaminants will not leave the province. In fact, we firmly believe that emissions will strongly impact the province of Quebec and that snow melt will cause episodic acidification and episodic pollution within Quebec also.

### 5- Also on page 8.

The IAA also writes "there will be no cumulative effect with other local projects".

The statement is totally erroneous in our opinion. First, the emissions from the cement plant should be cumulated with the quarry emissions, the lime plant emissions and the asphalt plant emissions which are all on the same geographic lot. Furthermore, there is also a-heavy industry less than 4 km east of the Project, the Ivaco Rolling Mills steel plant facility which emits 23 different pollutants, most of which are cumulative with the emissions produced by the Project.

In fact, using dioxins and furans as an example, Ivaco emitted 1.5755 g TEQ of dioxins and furans in 2017 while the proponent, if it had been in production then, would have emitted 0.536 g TEQ. Their combined emissions would have totalled 2.1115 g TEQ which would have made their cumulative emissions greater that any of the 123 other smoke stack emitters of dioxins and furans in all of Canada in 2017<sup>3</sup>.

#### 6- Also on page 8.

The IAA writes "Further, the proponent has committed to fulfill the notification obligations for the Canada-United States Air Quality Agreement". This is seriously questionable because neither the proponent nor the IAA **truly realize how much emissions will be discharged**.

#### 7- On page 9 (Concerning greenhouse gas emissions (GHG))

The IAA writes that "Predicted total greenhouse gas emissions 783 kilotonnes of carbon dioxide equivalents per year."

We strongly question this statement. First and foremost because the proponent has systematically underestimated emissions and its air quality expert, under oath, admitted of having confused United States short tons with metric tons (a 10.2% underestimation error)<sup>4</sup>. Metrication in

Canada began in 1970, more than 50 years ago. It is difficult to believe that this type of errors would be made in the twenty-first century.

These errors undermine the credibility of any facts, values, and reports that Colacem has submitted to obtain their Environmental Compliance Approval, including greenhouse gas emission calculations (see Appendix 4 of our petition for full details).

The Member of the Local Planning Appeal Tribunal even wrote in his Decision<sup>4</sup>:

- [40] ... The Tribunal ... notes that additional errors were revealed in subsequent cross examination.
- [45] Mr. Capstick's correction under oath implies that he may have misstated the conservativeness of his model to the MECP which granted the ECA.

According to our own calculations, using the mass balance that Colacem provided to a referee reviewing their project on behalf of the United Counties of Prescott-Russell in 2016, they will be emitting 832,942 tonnes a year of GHG. We used the Intergovernmental Panel on Climate Change (IPCC) methodology to estimate GHG emissions (see Section 7.4.5 of our petition and Appendix 1, Section 4.10, and Appendix 7).

According to the proponent's cover letter that was submitted to you through their counsel, Colacem's claims that their annual GHG emissions will be 783,702 tonnes a year based on maximum production. Considering the lack of credibility of most of the proponent's emission calculations (see Appendix 4 of our petition) and until their calculations have been validated by independent experts, it remains unsubstantiated in our opinion and it is very likely erroneous. We believe that our GHG emission calculations are more accurate.

The IAA also did not take into account the GHG that the heavy duty diesel transport trucks will be emitting. According to our conservative calculations, we estimate that there will be a yearly total of 94,076 truck trips (return trips included) outside of the Colacem's site to deliver cement powder or to collect raw material driving 9,598,127 kilometers a year, of which more than 60% will be driven in the province of Quebec.

#### 8- Also on page 9

The IAA wrote "This will provide a price incentive to reduce greenhouse gas emissions and spur innovation while maintaining competitiveness and protecting against carbon leakage."

We do not agree at all with this statement because of the federal government Output-Based Pricing System where cement plants are eligible to be reimbursed for 95% of the carbon taxes collected. It is likely that a similar system will be implemented by the Ontario government.

Even if Colacem used zero-carbon sources of energy to heat the kiln, it will still emit 519,480 metric tonnes a year of greenhouse gas from the limestone calcination process alone. In 2023, if the plant was operating at full capacity, this would represent a financial burden of over

\$32,000,000 that would have to be assumed by Canadian taxpayers. Colacem would have to pay \$1,688,310 (see Appendix 7, Section 6 of our petition). This is equivalent to putting 112,930 gasoline combusting cars on the road every year for the next 50 years. This represents a total of 26 Mt of GHG for the first 50 years that the plant will be operational, if they were to use green energy only, otherwise, the cumulative GHG will be 42 Mt.

## 9- On page 10

The IAA states that "Effects on migratory birds would be addressed through standard mitigation measures".

- a) For this Project, we believe that no agency, institution or organisation can make that claim since nobody has any idea of the magnitude of the emission levels that will be discharged by the Project, let alone their potential adverse effects. Consequently, how can the IAA be certain that "standard mitigation measures" will be sufficient?
- b) Furthermore, the spring snow melt effect, which will release pollutants that will have accumulated on the snow for 4 to 5 months, has not been taken into consideration. See also our Third comment at the top of this letter.
- c) Snow melt also coincides with the period when migratory birds reach our region. You even referred to the presence of migratory birds on the site (Page 10 of your slide deck, "47 bird species, 35 of which were migratory bird species, were observed on property, all commonly-observed species"). Migratory bird species are within federal jurisdiction, along with aquatic species and fish and fish habitat. All of those will likely incur adverse effects, whether they are on the Project site or within a 20 kilometres radius from the Project, which includes the Province of Quebec.

These are some of the reasons why an Impact Assessment should be done. This represents an important contamination risk to migratory birds which has not been considered but which is very real. We also believe that standard mitigation measures cannot alleviate the environmental contamination that follows snow melts.

#### 10- On page 11

Considerations – Indigenous Communities has been covered by our **second** comment at the top of this letter. The Kanesatake community stated that they were not consulted.

The IAA states "The proponent conducted archaeological studies according to Provincial requirements and addressed these considerations in project design." However, **this is no longer true**. While preparing this reply, we re-examined the Archaeological Assessment that the Proponent had commissioned. Although the area surveyed for the Stage 1 Archaeological Assessment only covered 32% of the current Project geographical lot, some artifact was found in this very small area<sup>5</sup>:

"This study concludes that the property in question has confirmed potential for the recovery of pre-historic materials. A celt was observed in situ in the northwest corner of the property." Page 35 of <sup>5</sup>

A Stage 2 Archaeological Assessment was further conducted, but only in the area south of the Drain Charlebois (40 hectares, 23% of the Project area) although the identified Aboriginal site was located north of the Drain Charlebois. Page 8 of <sup>5</sup>.

We believe that more Aboriginal archaeological materials are likely to be within the geographical area of the Project (174 hectares) and that it will be destroyed by the Project.

# 11- On page 12

The IAA states "ECCC advised the Agency that there was no Critical Habitat identified for any terrestrial species within 8 km of the proposed Project site".

We believe that there are Critical Habitats and species at risks within 20 km or more of the Project and that they all will be affected.

- a) We consider that the snow accumulation of pollutants will be important, at a minimum, within a radius of 20 kilometres from the Project, possibly 50 km or more which is another reason why an Impact Assessment should be done. As presented in previous sections, snow melt will likely release extremely contaminated water which will have an impact on Critical Habitats beyond the 8 km stated above and on species at risks.
- b) Possibly the snow melt release of pollutants will be limited in time to several weeks but the sudden and excessively high level of pollutants being released could be extremely detrimental to these habitats and to all species at risks within a minimum radius of 20 kilometres from the Project, both in Ontario and in Quebec.
- c) We believe that there are up to 14 species at risk on the Project itself. Even the person that did Colacem's field inventory/survey mentioned that some endangered, threatened and special concern species might be in the "significant woodland" present either on the section of the property that she did not survey or on properties adjacent. The same could be said for the wetlands on the Project's lot or adjacent to the lot. Considering that there were no surveys conducted on the majority of the Project lot that will be destroyed, the presence of any of these 14 species thriving there cannot be ruled out (see Appendix 6 of our petition).

#### 12-Also on page 12

The IAA states "Two species listed under Schedule 1 of the Species at Risk Act were between 1 km to 2 km from the proposed Project site". These species are very likely on the Project's lot but thorough and extensive surveys would be required to rule out their presence or absence. For these reasons, the IAA cannot rule out the presence of endangered or at risk species on the Project. In fact, we believe that there are up to 14 species at risk in the section that will be destroyed in the Project lot which, since 2021, is 174 hectares and not the 56 hectares in the original Nature Canada Designation request.

The snow melt effect will also have an impact on species at risks within at least a radius of 20 km.

# 13- On page 13

The IAA states "No evidence from publicly available information or in the request that the Project has changed since 2018". We totally disagree with this statement. Please see our **first** comment at the top of this letter.

Also, using publicly available information which your Agency did receive from Colacem on November 26, 2018, using our petition, and using the decision delivered in 2021by N.P. Robinson and order of the Local Planning Appeal Tribunal<sup>4</sup>, it should be apparent that the initial scale of this Project has substantially changed from its initial emission and environmental impact assessment. A total Project that, **for some of the pollutants, will be emitting 1,200% more in cumulative emissions** than what was initially submitted to the Ministry of the Environment, Conservation and Parks (MECP) and initially presented in Colacem's reports. This is why; again, we believe that no agency, institution or organisation has any idea of the magnitude of the emission levels that will be discharged by the Project. The scale of this Project has changed **dramatically** since it went from a regulated ECA with a known level of emissions to one that is purely speculative with no identified limits as far as emission levels are concerned. **This makes it a different Project**.

# 14- On page 14

The IAA writes "Is there important new information regarding potential adverse effects of the Project within federal jurisdiction or adverse direct or incidental effects? No"

We completely disagree as clearly identified in our petition. On the expanded lot of the Project, of which a total of more than 100 hectares will be destroyed, there are 15 federally listed species at risk that are or could be in the previously un-surveyed area. Until a full impact assessment is conducted, complemented by thorough and extensive surveys, the IAA cannot claim that there will not be potential adverse effects of the Project within federal jurisdiction or adverse direct or incidental effects. Our submitted Designation Request clearly made the IAA aware that the previous information was erroneous. The IAA answer should have consequently been YES.

In the case of migratory birds, spring snow melt can release relatively sudden and excessive level of contaminants that have been accumulating for 4 to 5 months. This phenomenon often coincides with the period when migratory birds reach our region. This **cumulative emission** of contaminants should not be ignored since it will expose migratory birds to pollutants levels far above what is considered acceptable. **The same reasoning applies to acid rain and to the 15 pollutants that can be bio-accumulated, as discussed in our third comment at the beginning of our letter.** 

Migratory bird species are within federal jurisdiction, along with aquatic species and fish and fish habitat. All of those will likely incur adverse effects because of snow melt, whether they are on the Project site or within a considerable radius from the Project, which includes the Province of Quebec. We think that this is information that had not been considered previously and that it warrants to be thoroughly investigated through an Impact Assessment.

# 15-Also on page 14

The IAA writes "The points raised in the letter as "new information" relate to the proponent's air emission models, which were used to support the application for the provincial ECA".

We disagree with this statement. At the time, your Agency believed that emissions would be within acceptable limits. Errors, omissions and misrepresentation were only discovered during the Local Planning Appeal Tribunal<sup>4</sup>: (see Appendix 4 of our petition for full details).

We consider that the IAA cannot have any idea of the magnitude of the emission levels that will be discharged by the Project; consequently they cannot claim that there will not be any adverse effects. Wrong emission values and models were used, which resulted in portraying the Project as being 1,200% smaller than it will really be, from a cumulative emission and activities point of view (see Appendix 4 in our petition). This is an altogether different Project from an ECA or other point of view as far as emissions and cumulative emissions are concerned. This is one of the reasons why an Impact Assessment should be done.

# 16- Also on page 14

The IAA writes "Potential environmental effects raised in the correspondence had already been considered in the 2018 request, or are not effects considered under ss. 9(1) of IAA."

We totally disagree. The Project portrayed in 2018 and the actual Project are two significantly different projects geographically (now 312% greater area), in scale of cumulative emissions (1,200% more for some pollutants), in identified species at risks (14 species) since the area that will be destroyed is more than three times what it was portrayed originally, and because we have demonstrated that there will be transboundary effects in the Province of Quebec and significant pollutants release in a radius of 20 km or more from the Project. We believe that the IAA does not have any idea of the magnitude of the emission levels that will be discharged by the Project, let alone their adverse effects. This is different than in 2018 when your Agency believed that the Project was presented as it would be operating. This is one of the reasons why a complete, impartial, and thorough impact assessment separate from the proponent's should be done.
