Context

Report to be presented by the company EVB Engineering regarding the structural investigations and designated substances survey for the Caledonia and St-Albert Community Centres.

Report

The RFP was awarded in January and included structural investigations as well as a designated substance survey for each building. Inspections were done in March and a preliminary report has been prepared for Council. The report summarizes all testing results, recommendations for remediation, additional testing, timing of events and estimated costs for the remedial work only.

Relevance to priorities

Asset management and the Parks & Recreation Master plan require that the buildings be inspected and that the municipality plans and prioritizes future repairs.

Financial Consideration

The request for proposal indicated that the repairs should be prioritized, and costs alotted for 2023, 1-2 years and 3-5 years.

Recommendation

The report is for information only, EVB Engineering will present their report to Council, answer questions and make recommendations and discuss an action plan.
